Plan for Improvement

Findings and Analysis: The Writing Center served 400 students during AY 21-22. During AY 22-23, the Writing Center served 425 students, resulting in an increase of 6.25%. The Writing Center did not reach its target of increasing student utilization by 10%. This was due to the staff shortage experienced by the Writing Center, which slowed down response time.

Plan for Improvement: While the Writing Center did increase student utilization of services, it did not achieve its target of increasing student utilization of services by 10% during AY 22-23. This target will be continued for AY 23-24. The Writing Center was able to increase the number of staff by hiring 1 full-time staff and securing 2 additional student workers, which will increase its ability to serve a larger number of students.

Plan for Improvement: The Communications Disorder Clinic will more specifically examine the intake assessment process during the next academic year (AY 23-34) in order to determine how to increase effectiveness in this area.
