New Business

Psychology Department

Steve Haggbloom presented the following three proposals:

▪Create a New Course – PSY 504, Advanced Research Methods in Psychology
There was a Berger/Powers motion to approve/second. The motion passed.

▪Revise Course Title – PSY 512, Seminar in Experimental Design
It was noted that this proposal should be to Make Multiple Revisions to a Course instead of Revise Course Title. This change was noted.
There was a Carter/Berger motion to approve/second. The motion passed.

▪Revise a Program – 092, Master of Arts in Psychology
There was a Powers/Carter motion to approve/second. The motion passed.

There was a Powers/Carter motion to approve/second. It was agreed that the implementation date be changed to spring, 2012. The motion passed.

There was a Powers/Berger motion to approve/second. Bruce Battles presented. The motion passed.
