New Business

Department of Psychology

Retta handed out a document from the ad hoc subcommittee appointed to discuss whether the college should develop a policy on academic integrity. The ad hoc subcommittee's recommendation to develop a college policy on academic integrity was summarized on a handout distributed by Retta. After discussion, Pam Petty moved, seconded by Bud Schlinker, to create another ad hoc subcommittee to draft a college policy on academic integrity and present the draft proposal to the CEBS Curriculum Committee for its consideration. The motion passed. After the start of the spring semester Retta will ask the members of the first ad hoc subcommittee to serve on the second subcommittee, and she will also work with CEBS Curriculum Committee members to identify additional faculty members to serve on the ad hoc subcommittee.
