Dr. Evans asked to add an item to the agenda regarding the admission of a student to the Professional Education Unit. There was a Love/Jones motion to approve the agenda as amended. The motion passed.

New Business

Office of Teacher Services-CEBS

- •Presentation of Candidates Completing Requirements for Admission to the Professional Education Unit January 14, 2010, to February 10, 2010. There was a Maples/Jones motion to approve/second. Ellen Gott presented and the motion passed.
- •A document showing two student teacher candidates for spring 2010 (one not qualified, one withdrawn) was for information only. No action required.
- •Ellen Gott presented information on a student (G.P.) to be recommended for certification in English grades 8-12 based on a proficiency evaluation as provided by 16 KAR 5:030. After some discussion, there was a Powers/Jones motion to approve/second this recommendation. The motion passed.
- •Ellen Gott reported that some applicants for student teaching in the spring 2010 semester did not meet the requirements in regard to critical performances and teacher dispositions.
- •Retta Poe moved to waive the student teaching requirement for this semester's applicants, that, on their critical performances, students must have earned at least a 2.5 average per Kentucky Teacher Standards, at least a 3.0 average overall on the critical performances, and disposition averages of at least 3.0. The motion was seconded by Libby Jones. Dr. Carter will be authorized to meet with students who did not achieve these criteria and use his judgment in working with each to be sure all are successful by the end of student teaching. This motion passed.
- •Tony Norman spoke about critical performance deficiencies.
