Department of Physics and Astronomy

Revise Course Prerequisites/Corequisites PHYS 410, Physics for Teachers There was a Croxall/Boman motion to approve/second. Keith Andrew presented. The motion passed.

■Revise a Program – 754, Major in Physics

There was a Zhang/Petty motion to approve/second. Keith Andrew presented. Adding PHYS 316 and PHYS 318 to the major provides students with experience in the use of physics-specific computer applications in a physics setting from either the applied problem-solving approach or from the data acquisition and interfacing approach. With the addition of the required three-hour physics course, the number of physics elective hours is reduced from nine to six so that overall total hours is unchanged. The motion passed.
