It was agreed to take the following two proposals together:

- •Multiple Revisions to a Course LTCY 320, Teaching Reading in Elementary School
- •Multiple Revisions to a Course LTCY 420, Reading in the Primary Grades

There was a Dietrich/Norman motion to approve/second. Jennifer Montgomery presented. The revised titles of these courses more accurately describe the content of these courses. The motion passed.

•Revise Course Prerequisites - TCHL 520, Principles of Action Research for Teacher Leaders There was a Norman/Dietrich motion to approve/second. Lisa Murley presented. Other Business

- •Sam Evans shared information from Commissioner Holliday on the Commonwealth Instructional Improvement Technology System.
- •Sam Evans reported that the Standards Board will meet on Monday, September 19th and a new 2.75 GPA for admission to undergraduate programs will probably be approved. He also mentioned that the ACT will not be a requirement for admission after the implementation date of the 2.75 GPA.
