# APPROVAL OF THE UNIVERSITY 2022-2028 SIX-YEAR CAPITAL PLAN

## **REQUEST**:

Approval of the University 2022-2028 Six-Year Capital Plan.

## FACTS:

Western Kentucky University's 2022-2028 Six Year Capital Plan was submitted to the Capital Planning Advisory Board (CPAB) and the Council on Postsecondary Education (CPE) on April 15, 2021.

The CPAB is comprised of members representing all three branches of government and has a responsibility under KRS Chapter 7A to biennially develop a comprehensive state capital improvements plan and to make funding recommendations to each branch head as to state spending for capital projects. Additionally, CPE will review these capital spending requests and will make recommendations for Postsecondary Education to the Governor and General Assembly for the 2022-2024 biennial budget.

In the process of developing the Six-Year Capital Plan, we incorporated the priorities contained in our 2021-2031 Campus Master Plan, solicited input from units across the campus and integrated our priorities with the capital priorities for higher education as outlined by CPE. This plan places a focus on our current WKU Strategic Plan 2018-2028, Climbing to Greater Heights and emphasizes capital renewal, renovation of existing facilities and upgrading our campus infrastructure. We believe that the top priority projects are reflective of the priorities for WKU and consistent with the direction of postsecondary education in Kentucky.

## **RECOMMENDATION:**

President Timothy C. Caboni recommends that the Board of Regents approve the 2022-2028 Six-Year Capital Plan.

## HONORIFIC NAMING REQUEST FOR BARBARA AND KELLY BURCH INSTITUTE FOR TRANSFORMATIVE PRACTICES IN HIGHER EDUCATION

#### **REQUEST:**

Approval of the honorific naming of the Kelly M. Burch Institute for Transformative Practices in Higher Education as the Barbara and Kelly Burch Institute for Transformative Practices in Higher Education in recognition of Barbara Burch's leadership and service to WKU as well as the long-lasting impacts of her work on the field of higher education at large.

## **FACTS**:

Dr. Barbara G. Burch, WKU Provost Emeritus, died on Jan. 5, 2020. Provost Emeritus Burch earned a bachelor's degree from WKU in 1959 before completing master's and doctoral degrees from Indiana University. She returned to Bowling Green, Ky., and WKU in 1996, where she continued to devote her professional career to higher education and civic engagement, as well as to being an entrepreneur.

Through her many roles, including Vice President of Academic Affairs, Provost, faculty member, Regent, Chair of the WKU Sisterhood, and founder of the Kelly M. Burch Institute for Transformative Practices in Higher Education, she demonstrated unwavering commitment to the faculty, staff, students, and future of WKU.

Provost Emeritus Burch's leadership extended beyond the Hill. Through her involvement in many national organizations, including service as President of the American Association of Colleges for Teacher Education as well as peer leadership in the American Association of State Colleges and Universities demonstrated through the creation of the American Democracy Project, her work will continue to benefit the broader higher education community for generations to come.

Dr. Kelly Burch, daughter of Drs. Barbara and Ken Burch, died on July 15, 2015. She received a master's degree in Mental Health Counseling from WKU in 1998, and she served as an Associate Professor of Marriage and Family Counseling at WKU for six years.

The mission of the Kelly M. Burch Institute for Transformative Practice in Higher Education is to serve as a catalyst in the cultivation and support of innovative practices and research initiatives related to student success that advance the mission of WKU and inform best practices in public higher education.

This honorific naming request is recommended in recognition of Provost Emeritus Barbara Burch's leadership and commitment to WKU.
