REQUEST: Approval for academic program suspension for: Strategic Sports Communications Graduate Certificate.

<u>FACTS</u>: The Faculty have made the decision regarding closing admissions to the Strategic Sports Communications Graduate Certificate program due to low enrollment. The Academic Program Coordinator, Department Chair, Dean, and Provost support this program suspension decision. WKU will continue to support current students through completion of their program.

The faculty made the decision to stop admitting students to this graduate certificate program during the program faculty meeting on 10/18/2022 due to low enrollment and a lack of qualified faculty to teach all of the required courses in the program.

<u>BUDGETARY IMPLICATIONS</u>: Closing this graduate certificate program to new admissions will have a positive or neutral impact on the University Budget because of the efficiencies created by greater utilization of faculty in higher demand programs.

UNIVERSITY DISTINGUISHED PROFESSOR **APPOINTMENT**

REQUEST: Approval of University Distinguished Professor appointment for Dr. Thomas Keith Philips, Professor of Biology, effective July 1, 2023.

FACT: Following a review of nominations, below is a faculty member who has been recommended by the University Distinguished Professorship Selection Committee and the Provost to be awarded University Distinguished Professor status effective July 1, 2023.

Dr. T. Keith Philips has brought distinction to the university through his internationally recognized, peerreviewed research. His program is broad, groundbreaking, often with international scientists and especially includes studies on spider beetles, dung beetles, and cave ground beetles. Dr. Philips is considered a world expert on these groups by his peers, has described and named numerous genera and species, and published important phylogenetic and other diversity studies in his career. He has involved many undergraduate and graduate students in various research projects and has provided them exemplary experiences overseas to numerous localities, such as Ghana, South Africa, Bolivia, Peru, and Chile. Dr. Philips' research techniques stay current with the latest developments in technology. The recently collected data from Eastern Kentucky caves was analyzed using a cutting-edge Next Generation Sequencing technique. He has received external grants from, for example, the National Science Foundation (BSI and EPSCOR programs), as well as successfully competing for internally available research money to make the most of every research opportunity. Dr. Philips has a strong commitment to helping students become thinking, engaged and socially responsible citizens and leaders.
