## Report to WKU Senate

## Kirk Atkinson, Chair - University Senate

The meeting was well-organized considering the number of people in attendance. There was vote to organization into the National Council of Faculty Senates (NCFS) and that interested parties would be a member as an institution not as individuals. This is intended to provide continuity in the organization as well as differentiate this group from other complementary ones like AAUP and AACU.

The primary goals were determined to be as follows:

- Support role
  - Mutual support for each other enhance and ensure effective governance across the different universities
  - Communication system to the university leaders and boards and coming up with solutions to faculty – administration / leader problems
  - Academic freedom and implementation thereof
    - Gears in place for faculty senates to support
  - Funding of faculty senates
- Help in implementing governance visions effectively
- Uniqueness vs complementary to AAUP
  - Nonpartisan focused on faculty concerns (AAUP is a political unit, we are practically-focused)
    - Still could advocate for politically charged issues as an organization of faculty senates vs individual faculty/faculties' concerns
- Advocating for the value of higher education
  - o Tenure in the 21st century

There will be an annual fee (unknown at this time) for membership and an annual conference. We will be considered Charter Members. I tentatively agreed to participate pending WKU Senate approval.

I recommend that we participate, at least through the charter process and better understand the direction. I further recommend that we take the lead in Kentucky to reenergize a Kentucky-based council of senates.
