APPENDIX B

From Scott Gordon:

Here is the final graduate enrollment management report for Spring 2019. As of census, enrollment was 2329, which is -247 compared to Spring 2018.

Several factors contributed to this enrollment decrease. Significant drops in resident students (-215) and international students (-51) were not offset by an increase in military enrollment (+30), while other classifications were flat. Within the resident population, the Kentucky counties showing the greatest change were Jefferson (-33), Fayette (-21), Daviess (-19), Hardin (-14), Grayson (-12), Warren (-12), Pulaski (-11), and Logan (+7).

From a degree level perspective, the largest decreases were in master's (-182) and non-degree (-47) enrollment. Each academic college (with the exception of the Gordon Ford College of Business) had fewer student enrolled this spring compared to last spring, with drop ranging from -109 to -31 (GFCOB was +5). Overall, full time enrollment increased slightly (+15) while part time enrollment dropped significantly (-262).

Note: this report uses unduplicated headcount, which counts each student only in their primary program/department. This predominantly affects certificate program enrollments, as they tend to be secondary programs. If you need more specific information about duplicated headcount (i.e., students simultaneously enrolled in multiple programs), please let me know.

WKU accepts transfer credit(s) earned at regionally accredited institutions of higher education. Students transferring credit from an international institution must submit an official transcript evaluation of credit from an international credential evaluation service recognized by the National Association of Credential Evaluation Services (NACES) before equivalencies are determined. All transfer coursework must be documented on an official transcript with a grade of "B" or better. Application of transfer credits toward program is subject to approval by the appropriate academic department.

2.2 Revised:

Program of Study

WKU accepts transfer credit(s) earned at regionally accredited institutions of higher education. Students transferring credit from an international institution must submit an official transcript evaluation of credit from an international credential evaluation service recognized by the National Association of Credential Evaluation Services (NACES) before equivalencies are determined. All transfer coursework must be documented on an official transcript with a grade of "B" or better. Transfer credits must be applied toward a graduate program awarded by WKU, are subject to approval by the appropriate academic department, and must comply with all other university policies.

3. Rationale for proposed policy:

3.1 The Graduate School (Graduate Dean) requests that the Graduate Council provide clarification on this policy. Currently, it is possible for a graduate student to take graduate level coursework elsewhere and transfer it to WKU in order to increase their overall GPA, even if that coursework is unrelated or not applicable to their program of study. This diminishes the ability to assess the true performance of students on degree program requirements, and allows for a diminishment of the Graduate School's requirement that students in good standing maintain a 3.0 or higher GPA.

4. Impact on existing academic or non – academic policies:

- 4.1 Impact on policies: no negative impact anticipated.
- 4.2 Impact on populations that may be affected: Students enrolled in graduate degrees will no longer be able to transfer non-program related courses to WKU.
