### I. Purpose and Scope

Western Kentucky University will honor select individuals, upon retirement, as emeritus faculty. These individuals will be granted certain rights and privileges in recognition of their honored role in the university community and their ongoing potential for contributions to the intellectual and cultural life of the university.

Beginning February 1, 2017, the title Emeritus will follow either a male or female faculty member's rank upon retirement (e.g. Professor of History, Emeritus).

### II. Policy

#### A. Faculty

To be awarded emeritus status, faculty must have served the university for at least 10 years. Faculty should have attained the rank of Professor, Associate Professor or Assistant Professor (under exceptional circumstances Instructors may be considered).

Emeritus faculty will be eligible for the benefits from the university accorded to retired faculty members, including such things as a university **retiree** identification card, **on campus** library privileges, ~~computing services~~, an email account, a parking permit, access to university recreational facilities, ~~the on-campus dental and outpatient medical services available to other faculty members~~, purchase of tickets to academic and athletic events at the prevailing faculty rate, enrollment in university classes under prices for faculty and staff, **and** purchase of items at the WKU Store at the prevailing prices for faculty and staff. ~~eligibility to apply for internal research grants, and continued use of the university as an~~

~~agent for external grant applications~~ Active Emeritus faculty may be nominated for Adjunct Faculty status with WKU Affiliate status, which can include additional IT Services and/or use of the university as an agent for external grant applications. Faculty Emeritus faculty may attend meetings of the Faculty University Senate and may participate in university academic processions and ceremonial events.

#### B. University Distinguished Professors

University Distinguished Professors may be similarly honored with emeritus designation upon retirement. University Distinguished Professors will carry the title University Distinguished Professor of [discipline], emeritus. Emeritus University Distinguished Professors will be eligible for the same or equivalent benefits to emeritus faculty.

#### C. Administrative Personnel

Academic administrative personnel may be similarly honored with emeritus designation upon retirement. Emeritus administrators will be eligible for the same or equivalent benefits to emeritus faculty.

### III. Procedure

#### A. Faculty

Recommendation for the emeritus appointment will originate in the home department. It is the responsibility of the department head/~~chair/director~~ to recommend retired faculty for emeritus status in a timely manner. Such recommendations will be based on the record of achievement and service of the faculty member during his/her career at the University, and supported by majority vote of tenured faculty in the home department and a brief rationale supporting their nomination to be shared with the Board of Regents. If supported by a majority, the nomination will proceed through administrative channels for approval by the department head, dean, Provost, ~~to the~~ and President, who will make recommendations to the Board of Regents for action.

### IV. Reason for Revision

#### November 2015

Non-substantive changes as part of the five year policy review per Policy 0.000V Policy on Policies.

#### January 2017

To clarify emerita/us recognition for faculty holding the University Distinguished Professor designation.

#### February 2017

The title Emerita will no longer be used as a designation for a female faculty member's rank upon retirement. The title Emeritus will be used for both male and female faculty members awarded this designation following the procedures indicated above. As of the date of this revision and in accordance with published policies, two-thirds of WKU's benchmark

institutions and three-quarters of Kentucky public universities award the title Emeritus to both male and female faculty members.

Board action would be required to change the title of Emerita to Emeritus for faculty members awarded this designation prior to February 1, 2017 and therefore those titles will remain unchanged.

#### January 2022

Policy changed to clarify computing and library services available to Emeritus faculty (email and on campus services), to transfer external grant application support from Emeritus to Adjunct Faculty, to remove reference to medical and dental services since those are available to the public, and to make expanded IT services available to those who earn Adjunct Faculty Status. Revision made to clarify the policy and that majority support for the department and support all the way up the chain is required.
